Registration by Post (Date : 7 - 12 August 2006)

The completed application form together with the following should be mailed to the registration place :

1. a photocopy of the candidate's Hong Kong Identity Card / Passport (for verification purpose only) which will be destroyed after the registration period;
2. a stamped (postage: \$2.2) self-addressed envelope for sending a demand note for payment of examination fee.

If a demand note is not received by 19 August 2006, the candidate should make an enquiry at 23277524.

Registration in Person/by a Representative

(Date : 14 - 31 August 2006; Time : Monday to Friday, 8:30am-5:00pm; Saturday, 9:00am-5:00pm)

Candidates may submit a completed application form in person or by a representative. A photocopy of the candidate's Hong Kong Identity Card / Passport should also be submitted by the representative for verification purpose.

On-line Registration (Date : 7 August (8:30am) - 31 August (5:00pm) 2006)

Candidates may submit the registration on-line (website : www.esdlife.com). He/She is required to provide an image file of his/her Hong Kong Identity Card / Passport (for verification purpose only) and settle the examination fee to complete the registration process.

考試費用

Examination Fee

A demand note will be issued to individual candidate at the time of registration. Entry to the examination will be invalidated if payment of examination fee is not made on or before the date stipulated on the demand note. No late payment will normally be accepted. If under special circumstances a late payment is accepted, a supplementary fee will be charged in addition to the normal examination fee. Fees paid are not refundable or transferable in any circumstances.

逾期報名

Late Entry
